Amber Heard's Lawyer Revealed Truth About Johnny Depp being Innocent

"I lied," she admits. Amber Heard admits to physically assaulting Johnny Depp. Depp and heard have been involved in a court battle for the last several years, with Heard filing for divorce and alleging that he physically harmed her.

Amber Heard, a 30-year-old actress, filed a restraining order against her husband, Hollywood actor Johnny Depp, in a Los Angeles court in May 2016.

She was swarmed by photographers, journalists, and video crews as she walked out of the building. There looked to be a mark on her cheek. Photographs of what seemed to be face bruises were also displayed to the court.

She said Depp had "violently" assaulted her and hurled a cellphone at her face with "great force" in a fit of fury. There were also claims of additional domestic violence events. "Excessive emotional, verbal, and physical abuse" as well as "angry, aggressive, humiliated, and frightening attacks," she said. Depp has rejected the allegations of abuse.

The restraining order was obtained, and the marriage ended shortly after.

The pair was back in court four years later, this time in London. Amber Heard, on the other hand, had not chosen to be in this situation. This was a libel suit filed by Depp against The Sun, a British tabloid.

His claim that the charges of physical assault were an "elaborate fraud" was at the center of the case. Depp hired one of the country's most well-known libel lawyers to attempt to disprove the charges.

Heard appeared in court every day for the next three weeks, walking past her ex-followers, husbands who were convinced that their hero was the victim and

that she was the one who had harmed him. Her tale, images, recollections, and the stories of her friends were all disclosed in court, and Depp's lawyers and supporters said they were part of a scheme to fraudulently establish that he was a "wife-beater," as The Sun had started in April 2018.

It wasn't only the spectators and the media who were keeping a close eye on things. Lawyers were already questioning what effect his victory would have on women who came forward with domestic abuse accusations if he won.

Each day, Johnny Depp would be greeted with applause outside. However, his actions and lifestyle were scrutinized, and a court has now found that The Sun's claims were "basically accurate."

It was an unusual court case.

The rest of the country was in lockdown, buses and streets in central London were desolate, and yet there was a gathering, sometimes exceeding 200 people, outside the Royal Courts of Justice. When Johnny Depp came, all efforts at social distance crumbled in the rush to grab a peek.

It was many strangers inside the High Court.

The Royal Courts of Justice are massive, gothic, and somber structures. Stone arches and somber tones characterize this space. In July, it was nearly deserted. I say nearly because there were a few people - a handful of journalists rushing past security, and a sprinkling of Depp admirers waiting in the halls and tunnels.

One lady showed me her arms, which were adorned with Johnny Depp tattoos. Every day, another guy costumed as Jack Sparrow, the star of Pirates of the Caribbean, came.

Then, every day about 10:00 a.m., they would congregate at Court 13's front entrance. They would give words of encouragement whenever Depp passed by, and at the conclusion of the case, he was spotted hugging them all. As he went into court, a little chorus of "Johnny, Johnny" could be heard.

He was on the witness stand ten minutes later, attempting to persuade a High Court judge that he was not a "wife abuser."

The allegations were really alarming. Heard said he had abused her on at least 14 times. She said she was in dread for her life at times and was left with a fractured nose, black eyes, and split lip. She said that she had been subjected to vicious, alcoholic tirades that had continued for days. A 15th complaint was also made, which was too distressing and sensitive to be heard in open court.

It seemed like a criminal trial; Depp was accused of assaulting his former lover on many occasions, the kind of violence that has landed others in jail. However, this was not a criminal case.

Because no one from The Sun was asked to testify, it was easy to forget this was a libel case between Depp and News Group Newspapers, the newspaper's proprietors. The writer Dan Wootton, whose story claimed there was "overwhelming proof" that the actor was a "wife abuser," was not even on the list of 79 persons named in the trial records.

And there was a long list of names. The case started with an email discussion between Depp and Sir Elton John about the dangers of addiction and then progressed with allusions to a befuddling cast of individuals. James Franco, Marilyn Manson, Elon Musk, Winona Ryder, Kate Moss, and Vanessa Paradis all appeared as special guests in a narrative that blew the Hollywood A-private list's world apart.

Text messages and video recordings of meetings in elevators were provided to us. The super-rich pays millions to preserve their privacy, yet here was a pair who revealed the contents of a telephone directory. No celebrity would undertake anything like this unless they believed there was something more at stake. That was Depp's way of regaining his reputation.

To prove 'fabricated' assault photos, Johnny Depp wins a bid for Amber Heard's phone records.

A judge has granted Johnny Depp access to his ex-wife Amber Heard's phone, which he thinks will show she lied about injuries he allegedly caused her.

The "Pirates of the Caribbean" star, who is suing Heard for \$50 million, alleges she doctored images claiming to show her with two black eyes, which she claims she received from the actor in 2015.

"Ms. Heard's counsel has presented these false images in deposition on several occasions," Depp's lawyer Benjamin Chew said in a court filing to the Circuit Court of Fairfax County, Va.

Depp, 58, is suing Heard, 35, in Virginia for an op-ed she published in the Washington Post in 2019 on domestic violence, which he claims was a defamatory assault on him.

Despite the fact that she did not identify Depp in the article, heard has previously claimed that she suffered two black eyes, a broken nose, and a fractured lip at his hands during a 2015 assault in Los Angeles, with images of the supposed injuries going viral.

"A lot of the shots have been processed through a photo — a photo editing tool called Photo 3 that can readily distort images such as presenting injuries when none really occurred," said Chew.

Depp's libel action against the UK's Sun tabloid for a story calling him a "wife abuser" was dismissed in November 2020.

Mr. Justice Nicol, the judge, said the Sun had shown that what was in the story was "essentially factual," and that 12 of the 14 purported domestic violence episodes had happened.

Chew stated in a recent Virginia court filing that the Sun's own expert decided that Heard's images from December 2015 that revealed damage to her face "were edited three years later."

"As a result, any modification of the trial package versions would have occurred on or after October 6, 2018," he said, adding that the expert discovered images from an iPad Pro 10.5 were generated on or after October 6, 2018.

"Three years later, Ms. Heard or someone acting on her behalf doctored those images. Ms. Heard wrongly denied it when it came up in her London testimony. In sum, Your Honor, Mr. Neu Meister cannot adequately examine or validate Ms. Heard's material without forensic imaging," he asserted.

She appeared on James Corden's talk show the day following the alleged assault, with Heard saying she was wearing thick makeup to disguise the bruises, according to the court.

Heard — who was married to the actor from 2015 to 2017 — wrote in an op-ed in December 2019 that she had "become a public figure embodying domestic violence."

Depp's name isn't mentioned in the work, but it's commonly assumed that it's about him. "I felt the full weight of our culture's anger for women who speak up," the actress wrote. Depp's lawyer, Adam Waldman, responded by claiming that the piece was an "abuse of the #MeToo movement" and that Heard "masquerades as a victim rather than the aggressor."

According to the lawsuit, Depp has lost money as a result of the allegations, including being fired from his role as Captain Jack Sparrow in the "Pirates of the Caribbean" movie. Depp's phone and laptop should not have to be turned up, the court said, since Heard's counsel had requested a "very wide" search.

Elaine Bredehoft, Heard's attorney, told Page Six that Heard "welcomes the chance to present her evidence in a jury trial, in a court of law" next year, saying that Depp and his legal team are seeking to test the case via the media.

"This is a nasty ploy by Mr. Depp's legal team to make false allegations while avoiding charges of defamation due to judicial immunity," Bredehoft remarked after Depp was judged to have committed many severe acts of domestic abuse against Amber Heard.
